### WHAT KIND OF BUSINESS DO YOU HAVE?



#### LARGE BUSINESS 200 kW or more

Typically includes hospitals, large educational facilities, large retail and office buildings and manufacturing facilities.



#### SMALL BUSINESS Fewer than 200 kW

Typically includes smaller retail establishments, offices, grocery stores, light manufacturing and restaurants.



#### **MUNICIPAL**

City and town accounts such as schools, fire and police stations, DPW facilities, town offices, water and wastewater treatment plants and pump stations.

#### FREE ENERGY ASSESSMENTS

Free walk-through energy assessments are available to **Small Business** and **Municipal** customers to help identify opportunities for improved energy efficiency.

#### **TECHNICAL ASSISTANCE**

NHSaves utility partners offer technical assistance, including project evaluation, identification of energy saving measures, energy audits, building commissioning and recommissioning studies and equipment monitoring. Our expertise can help ensure that you maximize your energy savings.

#### **INCENTIVES**

Incentives are available on a wide variety of equipment types to help save energy. These include:

- Chillers
- Compressed Air
- Heating, Ventilation and Air Conditioning
- Lighting and Controls
- Electric Motors
- Variable Frequency Drives
- Water Heating Equipment
- Refrigeration
- Food Service Equipment
- Weatherization

#### **NEW EQUIPMENT AND CONSTRUCTION**

New equipment and construction projects encompass two categories:

- 1. New buildings where equipment is being installed for the first time.
- 2. Existing buildings where current equipment has reached the "end-of-life" period and must be replaced.

#### **RETROFITS**

Retrofit refers to upgrading existing equipment to make it more energy efficient. Retrofit incentives include financial and technical services associated with installing new energy efficient equipment to replace old, inefficient equipment in existing facilities.

#### **PROJECT FINANCING**

Financing options may be available to help with energy efficiency projects. Contact your NHSaves utility partner to learn more.

#### **AVAILABILITY OF FUNDING**

All incentives are subject to funding availability. Certain caps and restrictions apply. Once you receive an incentive approval, your incentive is fixed and the money is reserved for your project.
