- Must be postmarked within 90 days of installation but no later than post mark **January 31, 2024**.

- Rebate cannot exceed purchase price.
- Limit of one variable speed pool pump rebate per year.
- Rebate cannot be combined with any other NHSaves rebates for the same unit.
