- Booster pumps are not eligible for rebate.
- Pump must be purchased and installed between January 1, 2025 and December 31, 2025.
- Rebate must be postmarked or submitted online no later than **January 31, 2026**.
- Rebate is a limited-time offer while funds are available, and may be subject to change at any time.
- Rebate cannot exceed purchase price.
- Limit of one variable speed pool pump rebate per year.
- Rebate cannot be combined with any other NHSaves rebates for the same unit.
